The Consultant will render support/assistance to the concerned Administrative Officers in DRI HQ. The Consultant will function under the control of Addl. /Joint Director(Administration) in the DRI HQ during the period of engagement.

2. The interested person must possess the essential qualification of having at least 25 years of working experience in Administrative and Accounts related matters and should have retired as a Gazetted Officer, preferably from the Department of Revenue.

The selected officer will be engaged as Consultant for his/her advisory on Budget work related to BE, RE, FR and head-wise distribution, Monitoring office expenditure, Audit references and any other Accounts/Establishment related work in Directorate of Revenue Intelligence HQ. The Consultant as engaged shall be eligible for a consultancy fee on monthly basis as per the existing GFR. The Consultant so appointed, however, will continue to draw his/her pensionary benefits as admissible under the rule. The consultant shall not be entitled for any allowance such as Dearness allowance, Residential Telephone, Transport facility etc.
