Subject: Preparation of panel for appointment as **Intelligence Officer** on deputation basis in the Directorate of Revenue Intelligence, located at Ahmedabad/Surat/Gandhidham/Jamnagar in the pay scale of Rs.9300-34800/- (Revised Pay Band) plus Rs.4600 (Grade Pay) as applicable- reg.

The Directorate of Revenue Intelligence, Ahmedabad Zonal Unit (DRI, AZU) is in the process of drawing a panel of suitable candidates for filling up the existing/anticipated vacancies in various units of DRI, AZU located at Ahmedabad, Surat, Gandhidham, Jamnagar and two sub-units proposed to be created at Vapi and Bhavnagar, in the grade of Intelligence Officer in the pay scale of Rs.9300-34800 {Pay Band plus Rs.4600(Grade Pay)}. The selected IOs are entitled to draw special pay of 10% of basic pay as defined in FR 9(21)(a)(I) in the revised scale subject to the prescribed ceiling of Rs.2000/-per month.

2. It is proposed to fill up the vacancies by appointing suitable officers on deputation or loan basis with a minimum of three years of service in the grade of Inspectors.

3. Normally, the deputation is for a period of five years, which is extendable by another two years, subject to the willingness of the officers, evaluation of his/her performance, and the concurrence of his parent department. It may be made clear to the willing officers that the option once exercised would be final and in the event of selection, they will not be allowed to withdraw the same.


4. Further as per para IV of Ministry's F.No. A-35017/28/92-AD.III B dated 30.06.2004, officers posted in certain charges/organization/assignments are required to complete the 'Cooling Off' period of not less than two years before posting in this organization. However, the concerned Chief Commissioner of Customs/Central Excise can relax the 'Cooling Off' period, in suitable cases, if deemed appropriate.

5. It is requested that the circular may be brought to the notice of all the formations in your jurisdiction and the applications of willing officers shall be forwarded to this office. While forwarding the names of the willing officers, the following information in respect of them may also be sent for evaluation by this Directorate:

- (i) Bio-data and willingness of the officer along with history of previous posting.
- (ii) No objection Certificate from Chief Commissioner to relieve in the event of his selection.
- (iii) ACR grading for the last 5 years including 2012-13 duly verified and attested.
- (iv) Vigilance Clearance Certificate.
- (v) Chief Commissioner's concurrence.
