NOTICE INVITING TENDER / RFP

On behalf of the Directorate of Revenue Intelligence, Zonal Unit, Ahmedabad, sealed tenders are invited from Telecom Service Providers/Carriers for the following purpose:

Sl. No.	Service	Quantity
(i)	Supply, Installation, Commissioning and Running of Multi-Protocol Label Switching (MPLS) based VPN solution for period of one year extendable on satisfactory service. The Hub Location and aggregation point shall be in DRI Office at Ahmedabad. (a) No of Location with 2 MBPS connectivity – 7 [Sl. no 1-7] (b) No of Location with 1 MBPS connectivity – 3 [Sl. no 8-10]	As per Annexure A

2. The tendering firms are requested to submit their sealed offer in two parts: "Technical Bid" and "Financial Bid". The technical bid and financial bids are to be submitted simultaneously in two separate sealed envelopes clearly super scribed 'Technical Bid' and 'Financial Bid' in bold letters. Both the offers should be kept in one sealed envelope super scribed with "**Tender for MPLS Based VPN Solution**".

3. In financial bid, only the bid amount should be written in numbers as well as in words.

4. The technical bid of the tender should enclose detailed description of the Hardware, Software & Peripherals. A summary of the offer should also be provided as part of the **technical bid**, in the format enclosed herewith as Annexure – B. The technical bid should also include screen shots / graphics of the various important features provided by the software solution.

5. **Financial Offer:** Tendering firms are required to quote base rate, GST, etc. separately, if applicable. Rates should be quoted F.O.R. Ahmedabad for a period of one year.

6. **Delivery Period:** 30 days from the date of receipt of the order. If supply is not completed within stipulated time, then penalty @ 1% per day of contract price would be imposed for maximum of 15 days. After that, in case of inadequate reason for delay, the purchase order may be cancelled.

7. **Past performance:** Tendering firms are required to give their past performance certificate, indicating the names of agencies to whom these equipment / software has been supplied.

8. **Terms of Payment:**

(a) 75% of contract price of equipment shall be paid on delivery inspection & successful Commissioning of equipment.

(b) Rest 25% of contract price of equipment shall be paid after 3 Months on satisfactory working of system.

9. The tenderer will specify after sales service and support mechanism clearly in the bid. Frequency of routine maintenance during warranty period and breakdown maintenance should also be clearly specified. The SLA which will be provided including the last mile connectivity should be spelt out clearly for each segment / section of the MPLS VPN network. The tenderer should also inform whether spare equipment is maintained as part of the inventory to confirm to SLA.

10. Unless the last date for supply of stores is specifically extended by the purchaser, the supply order is liable to be cancelled after the expiry of stipulated period. In case the tenderer experiences some genuine problem in supplying the stores within the stipulated period, they are advised to promptly seek extension of delivery period, which may be allowed at the sole discretion of the purchaser.

11. Tenderers are required to submit valid GST Registration No. & Income Tax PAN along with the technical offer.

12. The last date of submission of the Bid/Quotation is 17.09.18 at 1600 Hrs. The bid/Quotation may be submitted in person to Shri Arvind Kumar Chaurasia, Dy. 13. All the tendering firms are advised to authorize the person's Name who will be signing the tender documents.

The tendering firms will be required to enter into a **Non Disclosure Agreement** with the Office of the Additional Director General, Zonal Unit, Ahmedabad regarding confidentiality of equipment, data and any other information related with above equipment shared during the process of supply, installation & maintenance.

15. The Additional Director General, Zonal Unit, Ahmadabad is empowered to accept or reject any tender without assigning any reason.
