- a) Five exceptional contributions or noteworthy achievements during the service (in not more than 100 words)
- b) Brief description of work that can be classified as that of high professional merit & excellence in the service (in not more than 100 words); and
- c) Statement of purpose (in not more than 100 words).

4. It is requested that you may verify the information furnished by each applicant and forward the applications to the undersigned latest by 27.02.2026. The application must be forwarded by the concerned Member/Pr. Director General/ Pr. Chief Commissioner/ Director General/ Chief Commissioner. For officers on deputation, duly verified application may be submitted through their Competent Authority.
