Subject : Preparation of panel for appointment of **Intelligence Officer** in the Directorate of Revenue Intelligence, Zonal Unit, Ahmedabad and Regional Unit, Gandhidham in the Pay Band - 2 of Rs. 9300/- - 38400/- + Grade Pay of Rs. 4600/- on Loan Basis - Reg.

The Directorate of Revenue Intelligence, Zonal Unit, Ahmedabad is in the process of drawing up a panel of suitable candidates for filling up posts of **Intelligence Officer at Zonal Unit, Ahmedabad and Regional Unit at Gandhidham**. It is proposed to fill up these vacancies by appointing suitable officers from the grade of Superintendents of Customs & Central GST on Loan Basis.

2. It is requested that directions may kindly be issued to bring the above to the notice of all the formations under your jurisdiction and that the applications of willing officers may kindly be forwarded to this office. While forwarding the names of willing officers, it is requested that the following information about them may also be sent for the purpose of evaluation of their suitability for this Directorate.

- (i) Willingness letter of the Officers along with **History of previous postings;**
- (ii) **ACR / APAR Gradings for the last 5 years duly verified and attested by the Additional / Joint Commissioner (P&V) and**
- (iii) **Vigilance Clearance.**

3. The tenure of selected officers, while working in Directorate of Revenue Intelligence in the grade of Intelligence Officer on Loan / Rotational Transfer will be Two Years initially. It may be made clear to the willing officers that the option once exercised would be final and in the event of selection, they will not be allowed to withdraw the same. Also, that they will have to make their own arrangements for residential accommodation.


