Terms and Conditions for the Hiring Digital Forensic Services

- 1. DRI(Hqrs), New Delhi invites sealed bids from bona-fide reliable and resourceful service providers experienced in the field of Digital forensic service for specific services for the office of the DRI(Hqrs).
- 2. The professional skills required are:
 - (a) Forensic acquisition / Imaging of different types of storage media such as hard Drives, USB thumb drives, CDs/DVDs, Tablets, Servers etc. Retrieval of deleted files, cracking passwords from suspected computer (source, and preparing separate working copies by using legal and most efficient and updated forensic tools, etc.
 - (b) Analysis of Digital evidence: Registry analysis, metadata analysis, RAM Analysis, Data Carving. Timeline Analysis, Data Retrieval, Active file analysis, decryption, and password cracking: hidden file analysis, web artifact analysis, keyword search etc.
 - (c) Email Forensics, indexing of mails, time-line analysis, keyword searching etc.
 - (d) Mobile Forensics Logical and Physical extraction of mobile phones/ all kinds of smartphones including I-phones, I-pads etc.; data extraction and analysis, SIM card analysis etc.
- 3. The Applicant Service Provider should have in their employment/services, qualified digital forensic specialists with minimum 5 years' experience preferably handling the cases relating to the investigation wing of Customs or other Central/State Enforcement Agencies and should possess all updated/latest versions of the Cyber tools such as oxygen forensic, encase, Cellebrite. X-ways, Phone Rescue etc Number of digital forensic specialists available with the applicant should be indicated with the bid.
- 4. Applicant contractors should have a reputed client base. The client list should be submitted with the bid.
- 5. The Applicant contractor should preferably have a Pan-India presence, atleast in cities having DRI ZUs, RUs & SRUs (locations of DRI offices Pan-India may be seen at DRI website (URL: www.dri.nic.in) or should be able to send teams at short notice to outstations.
- 6. The Applicant contractor' should ensure that the resource persons are made available as and when required by the officers of the office of the DRI(Hqrs), New Delhi even at a short notice. The vendor should make available full-time resources (which is typically around 10-15 people) plus additional resources as required.
- 7. The vendor should provide the list of engineers (with their qualifications and experience) who are part of the team with the tender, any new person will have to be cleared by the Department before being inducted into the team.
- 8. The applicant contractor should ensure compliance of strict confidentiality of data and procedures, as the matter dealt with will be of high sensitivity and utmost importance.
- 9. The DRI(Hqrs) reserves the right of accepting the whole or any part of the quotation received and the contractor shall be bound to perform the same at the rates quoted.
- 10. The bidder is requested to make the Earnest Money Deposit (EMD) of Rs.20000/-(Rupees twenty thousand only), refundable (without interest), accompanied with the Technical bid in the form of Demand Draft/Pay Order from any of the scheduled Banks drawn in the favour of Pay & Account Officer, HQ, C.R. Building, New Delhi, payable at New Delhi, valid for a period of 90 days.

- 11. On acceptance of the successful bid, the service provider has to submit performance guarantee of an amount of Rs.1 Lakh for the entire period of the contract in the form of Bank Guarantee from a Nationalized Bank drawn in favour of Pay & Account Officer, (HQ), C.R. Building, New Delhi after the awarding of contract. The performance Guarantee should remain valid for a period of sixty days beyond the date of completion of contract.
- 12. A consolidated bill will be submitted after the satisfactory completion of the work for payment the bills will also be countersigned by the relevant officers before submitting the same. The bills will be cleared within a reasonable time. However, in case of any unexpected delay, the contractor should be in a position to offer a credit facility for the period.
- 13. TDS and GST will be made as per law.
- 14. The contract could be terminated without assigning any reason by this Directorate any time.
- 15. Suitable penalty will be imposed by this Directorate as decided for refusal of service/ discrepancy and delay in service.
- 16. The Technical bid should be as per Annexure-II and Financial bid as per Annexure -III otherwise vendor will be considered disqualified.
