Subject: - Preparation of panel for appointment of Intelligence Officer (IO) on Deputation & Loan basis in the Directorate of Revenue Intelligence (Hqrs.), New Delhi - Reg.

Applications are invited to fill up posts in the grade of Intelligence Officers on Deputation & Loan basis in the DRI (Hqrs.), New Delhi.

2. These posts will be filled up on deputation & loan basis from amongst the officers of the similar ranks working in the formation of CGST, Customs & Central Excise and from amongst officers holding analogous posts in the Directorates under CBIC in the same pay scale.

3. The officers selected on deputation, while working in the Directorate of Revenue Intelligence in the grade of Intelligence Officer, will be entitled for a deputation (duty) allowance in terms of DoP&T OM No. 2/11/2017-Estt.(Pay-II) dated 24.11.2017.

4. Now, the deputation is for a period of three years which is not extenable as per new RR' dated 13-03-2024 issued by DGPM.

5. The period of loan basis is initially for two years and can be further extended for one year at the discretion of the competent authority with the concurrence of the cadre controlling authority concerned. Further, as per Board F. No. A-11013/12/2019-Ad.IV dated 27.05.2020 in exceptional circumstances, for justifiable reasons, Board may extend the tenure of the officers beyond 3 years.

6. Applications of interested officers may be forwarded by CCAs to the Additional Director (Admin), DRI (Hqrs.), New Delhi at drihqrsadmn-cbec@nic.in along with the following information: -

- i. Complete bio-data and willingness of the officer along with History of previous postings.
- ii. ACR/APAR grading for the last 05 years including the year 2023-24 (duly verified and attested by the Addl./Joint Commissioner (P&V).

- iv. 'No Objection Certificate' from the CCA to relieve the officer in the event of his/her selection.
- v. Experience in Anti Smuggling, Investigation, Data Analytics, Important Cases being handled and other relevant details.

7. In case, while working in this Directorate, the work & conduct of the officer is not found to be satisfactory, the officer can be reverted to the parent Commissionerate/Directorate before completion of loan period.

8. Selected officers will have to make their own arrangements for residential accommodation.

9. The officers selected on loan basis will continue to draw their salary & other allowances from their parent Commissionerate/Directorates as per rule.

10. It is requested that this notice may be widely circulated amongst officers under your jurisdictions. Eligible applicants may submit their application through proper channel on or before 08/08/2025 and an advance copy may be forwarded to drihqrsadmn-cbec@nic.in.
