NOTICE INVITING TENDER

Office of the Additional Director General, Directorate of Revenue Intelligences, Mumbai Zonal Unit, Mumbai, 13 Sir Vithaldas Thackeray Marg, New Marine Lines, Opp. Patkar Hall, Mumbai-400020 invites sealed tender from technically qualified and competent software developers for the development of following software for this Directorate.

Sl. No.	Name of work	Quotation amount along individual taxes applicable separately
1	Designing/Programming of Offence data recording software with user friendly interface for the recording, storing, reporting and generation of progressive, periodical and custom made reports in respect of the offence cases registered mainly by the offices of DRI, Customs and other offices under the CBEC in the entire country and COIN offices abroad. The various stages of data entry into the software will include the details from the stage of initiation of a case till the distribution of final rewards to informers and officers.	
2.	The system should be developed as a web browser based application using PHP and JAVA platform deployed on APACHE web server running on HP UX/LINUX server.	
3	The system should also be expandable to incorporate similar requirements for recording the cases detected by the Central Excise and Service tax Commissionerates.	
4.	The software should also contain tools facilitating to record details of detection, investigation, issue of show cause notice, adjudication, appeal, settlement, prosecution, recovery, cofeposa detention etc of a case.	
5.	Report building tools should have the capacity to generate periodical predesigned and custom made reports for any given period.	
6.	The access to this system will be for unlimited number of users by the offices under CBEC across the country.	
7	The annual maintenance charge for maintaining the system after the development and commissioning of the same.	

The terms and conditions of the tender are as follows:

1. The tenderer may if required visit the office of Deputy Director, Commercial Intelligence Cell, situated at the 5th Floor, UTI Building, Sir Vithaldas Thackersey Marg, New Marine Line, Churchgate, Mumbai 400020 to understand anything more about the said software being developed. Tenderer shall be deemed to have considered all the said aspects whether he has inspected it or not and to have satisfied himself in all respect before quoting his rates and no claim or extra charges whatsoever in this regard shall be entertained/payable by Directorate of Revenue Intelligences at a later date.

2. All preparatory work including statutory requirements for the use of legal software and hardware requirements towards the development shall be the responsibility of the tenderer and no extra charges in this regard shall be payable by this office.

3. The contractor shall depute well qualified staff having sufficient experience in execution of such works. The allotted work has to be completed with three months from the date of order for which arrangement of suitable number of technical personnel has to be arranged by the tenderer.

4. The rates quoted by the tenderer shall be firm and fixed for the entire completion of the work.

5. The person engaged by the tenderer will be in the employment of the tenderer only and not in DRI. The DRI is no way concerned with the employees engaged by the tenderer.

7. The tenderer/contractor shall be responsible for complying with the applicable laws/bye laws/Regulations in force from time to time.

8. The tenderer/Contractor shall be fully responsible and liable for the payment of all taxes duties, tolls, octroi duties, excise duty, cess / royalty etc. on all material and articles that contractor may use for this work. Any increase in the aforesaid taxes, duties, levies, cess / royalty etc. that may arise during the currency of the contract shall also be on contractor's account and shall not be paid / reimbursed to the contractor by Directorate of Revenue Intelligence.

9. Directorate of Revenue Intelligence shall deduct Income Tax at source from all payments due to contractor under this contract in accordance with the Income Tax Act, 1961 and rules made there under including any amendments or modifications thereof till date.

10. Payment will be released after completion of the work, submission of the bill and usual processing thereof.

11. The successful tenderer /contractor should furnish adequate and reasonable warranty in respect of the software and its functions.

12. The sealed tenders will be accepted in the Ground floor, Directorate of Revenue Intelligences, Mumbai Zonal Unit, Mumbai, 13 Sir Vithaldas Thackeray Marg, New Marine Lines, Opp. Patkar Hall, Mumbai-400020 up to 07.07.2014 at 2.30 p.m. The bids will be opened on 07.07.2014 at 4.30 p.m.


13. The sealed tenders should be on the letter head of the company/firm and the terms of quotations and its acceptability must be clear. The tenderer must also enclose copies of the work order/Invoice etc. if any, evidencing having done similar work earlier.

14. The Directorate of Revenue Intelligence reserves to itself the authority to reject any or all the tenders received without assigning any reason. Directorate of Revenue Intelligence also reserves the right to Split the work among two or more parties at lowest negotiated rate without assigning any reason thereof. The contractor is bound to accept the portion of work as offered by Directorate of Revenue Intelligence after split up at the quoted/negotiated rates. Further, Directorate of Revenue Intelligence reserves right for the allotment of the work in full or in part also to the successful tenderer.
