Applications are invited to fill up the following posts on loan basis in the DRI (Hqrs.), New Delhi.

2. These posts will be filled up on loan basis from amongst the officers working under CGST & Customs formations and from amongst officers holding analogous posts in the Directorates under CBIC in the same pay scale.

3. The period of loan basis is initially for two years and can be further extended for one year at the discretion of the competent authority with the concurrence of the cadre controlling authority concerned. Further, as per Board F. no. A-11013/12/2019-Ad.IV dated 27.05.2020, in exceptional circumstances, for justifiable reasons, Board may extend the tenure of the officers beyond 3 years.

'No Objection Certificate' from the CCA to relieve the officer in the event of his/her (iv) selection.

In case, while working in this Directorate, the work & conduct of the officer is not 5. reverted the parent to can be officer found to be satisfactory, the Commissionerate/Directorate before completion of loan period.

Selected officers will have to make their own arrangements for residential 6. accommodation.

The officers selected on loan basis will continue to draw their salary & other 7. allowances from their parent Commissionerate/Directorates as per rule.
